Immigration fees are going up at the end of July!

Make an appointment NOW to file your application before July 25th, 2007!

Q: How much are immigration fees increasing?

A: Form & Benefit applied for <i>The fees for all immigration applications are increasing by an average of 66%. The forms listed below are examples of applications used by our clients.</i>	Current Fee	Fee as of 7/30/07
I-90: Application to replace permanent resident card	\$260	\$370
I-130: Family petition	\$190	\$355
I-485: Adjust status and become a permanent resident while in the U.S., including the fee for employment authorization	\$575	\$1,010
N-400: Naturalization—application to become a U.S. Citizen	\$400	\$675

Please note that the fees above include the biometrics fee, but do not include the fee charged by the agency or attorney for representation with USCIS.

Q: Where can I receive assistance in filing my application?

A: A non-profit agency that has been accredited by the Board of Immigration Appeals (BIA) to practice immigration law OR an immigration attorney. Accredited agencies are listed below and attorneys are listed on the back of this flyer.

Q. What is an accredited representative? Why is it important to use one?

A: A BIA accredited representative must be the member of the staff of a BIA-recognized agency and have a required level of experience in and knowledge of immigration law to provide immigration legal services. Only BIA-accredited representatives and attorneys can represent clients at immigration interviews and in immigration court.
